### Child Safeguarding Statement

St Mary's Primary School is a primary school providing primary education to pupils from Junior Infants to Sixth Class.

In accordance with the requirements of the [Children First Act 2015](#), [Children First: National Guidance for the Protection and Welfare of Children 2017](#), [the Addendum to Children First \(2019\)](#), the [Child Protection Procedures for Primary and Post-Primary Schools \(revised 2023\)](#) and [Tusla Guidance on the preparation of Child Safeguarding Statements](#), the Board of Management of St Mary's Primary School has agreed the Child Safeguarding Statement set out in this document.

- 1 The Board of Management has adopted and will implement fully and without modification the Department's *Child Protection Procedures for Primary and Post-Primary Schools (revised 2023)* as part of this overall Child Safeguarding Statement
- 2 The Designated Liaison Person (DLP) is **Siobhán Nally**
- 3 The Deputy Designated Liaison Person (Deputy DLP) is **Fiona O' Brien**
- 4 The Relevant Person is **Siobhán Nally**  
*(The relevant person is one who can provide information in respect of how the child safeguarding statement was developed and will be able to provide the statement on request. In a school setting the relevant person shall be the designated liaison person.)*
- 5 The Board of Management recognises that child protection and welfare considerations permeate all aspects of school life and must be reflected in all of the school's policies, procedures, practices and activities. In its policies, procedures, practices and activities, the school will adhere to the following principles of best practice in child protection and welfare:

The school will:

recognise that the protection and welfare of children is of paramount importance, regardless of all other considerations;

- fully comply with its statutory obligations under the Children First Act 2015 and other relevant legislation relating to the protection and welfare of children;
- fully co-operate with the relevant statutory authorities in relation to child protection and welfare matters;
- adopt safe practices to minimise the possibility of harm or accidents happening to children and protect workers from the necessity to take unnecessary risks that may leave themselves open to accusations of abuse or neglect;
- develop a practice of openness with parents and encourage parental involvement in the education of their children; and
- fully respect confidentiality requirements in dealing with child protection matters.

The school will also adhere to the above principles in relation to any adult pupil with a special vulnerability.

- 6 The following procedures/measures are in place:
  - In relation to any member of staff who is the subject of any investigation (howsoever described) in respect of any act, omission or circumstance in respect of a child attending the school, the school adheres to the relevant procedures set out in Chapter 7 of the *Child Protection Procedures*

for Primary and Post Primary Schools (revised 2023) and to the relevant agreed disciplinary procedures for school staff which are published on the gov.ie website.

- In relation to the selection or recruitment of staff and their suitability to work with children, the school adheres to the statutory vetting requirements of the [National Vetting Bureau \(Children and Vulnerable Persons\)](#) Acts 2012 to 2016 and to the wider duty of care guidance set out in relevant Garda vetting and recruitment circulars published by the Department of Education and available on the gov.ie website.
- In relation to the provision of information and, where necessary, instruction and training, to staff in respect of the identification of the occurrence of harm (as defined in the 2015 Act) the school-
  - Has provided each member of staff with a copy of the school's Child Safeguarding Statement
  - Ensures all new staff are provided with a copy of the school's Child Safeguarding Statement
  - Encourages staff to avail of relevant training
  - Encourages Board of Management members to avail of relevant training
  - The Board of Management maintains records of all staff and Board member training
- In relation to reporting of child protection concerns to Tusla, all school personnel are required to adhere to the procedures set out in the *Child Protection Procedures for Primary and Post Primary Schools (revised 2023)*, including in the case of registered teachers, those in relation to mandated reporting under the Children First Act 2015.
- All registered teachers employed by the school are mandated persons under the Children First Act 2015.
- In accordance with the Children First Act 2015 and the Addendum to Children First (2019), the Board has carried out an assessment of any potential for harm to a child while attending the school or participating in school activities. A written assessment setting out the areas of risk identified and the school's procedures for managing those risks is included with the Child Safeguarding Statement.
- The various procedures referred to in this Statement can be accessed via the school's website, the gov.ie website or will be made available on request by the school.

**Note:** The above is not intended as an exhaustive list. Individual Boards of Management shall also include in this section such other procedures/measures that are of relevance to the school in question.

# Child Safeguarding Risk Assessment

## Written Assessment of Risk of St Mary's Primary School

In accordance with section 11 of the Children First Act 2015 and with the requirements of Chapter 8 of the *Child Protection Procedures for Primary and Post Primary Schools (revised 2023)*, the following is the Written Risk Assessment of St Mary's Primary School.

### 1. List of school activities

#### Daily arrival and dismissal of pupils

School Teaching Hours 9:10 AM - 2:50 PM

#### In-School Tuition

Mainstream Classroom, Special Ed Withdrawal, Speech and Language therapy language classes, Computer Time, Library Time, PE, PMP, Sound Therapy, Neuro-developmental Therapy, Bilateral Integration, Cookery, Gardening, Ukulele lessons, Rugby

**Recreational time:** Outside the school building before school, 10:50am - 11:10am break, 12:30pm - 12:50pm break, indoor breaks on wet days

#### Outside School hours Activities:

Homework Club, Committee meetings during lunchtime, Choir, Banna Ceoil, Green Flag, Student Council, Gaelbhreach, Healthy Schools, Active Schools Week, COW Cycling on Wednesdays before school, school sports.

**Field Trips: including-** Mass/Church visits, Swimming, River walks, School tours/outings, Nature walks, Trips to the Shop/Castle/Playground, Playground time, Competitions -Athletics, Sports Day, Spelling Bee.

**Special Occasions:** St Patrick's Day parade, Sixth Class Graduation, First Class Graduation

**Visits from outside school personnel:** Guest speakers, visiting teachers, Demonstrations, Drama groups, a Garda, the Chaplain, Secondary School Principals, TY students on work experience, Student Teachers on Teaching practice, GAA personnel, SNAs on placement, Irish Dancing teachers, Ukulele teacher, Parent Association and helpers, HSE personnel, Active Schools Week, instructors, Substitute teachers/SNAs, Readers, Speech & Language Therapists, Occupational Therapists, Photographer, builders/contractors, Anti- Bullying Speakers, Green Flag instructors and facilitators, Other coaches, Leinster Rugby, Golf Ireland personnel

- School Transport Arrangements involving Bus escorts
- Care of children with Special Needs including intimate care needs
- Administration of medicine/first aid
- Use of Media/photography etc to record school events

### 2. The school has identified the following risk of harm in respect of its activities -

- Risk of harm not being recognised by school personnel
- Risk of harm not being reported properly and promptly by school personnel
- Risk of a child being harmed in the school by a member of school personnel
- Risk of a child being harmed in the school by another child
- Risk of a child being harmed in the school by volunteer or visitor to the school
- Risk of a child harming himself/herself

- Risk of a child being harmed by a member of school personnel, a member of staff of another organisation or other person while child participating in out of school activities e.g. school trip, swimming lessons, cycling
- Risk of harm due to inappropriate use of online remote teaching and learning communication platform such as an uninvited person accessing the lesson link, students being left unsupervised for long periods of time in breakout rooms
- Risk of harm due to the bullying of a child
- Risk of harm due to racism
- Risk of harm due to inadequate supervision of children in school
- Risk of harm due to inadequate supervision of children while attending out of school activities
- Risk of harm due to inappropriate relationship/communications between child and another child or adult
- Risk of harm due to children inappropriately accessing/using computers, social media, phones and other devices while at school
- Risk of harm to children with SEN who have particular vulnerabilities including medical vulnerabilities
- Risk of harm caused by a child being a flight risk
- Risk of harm to child while a child is receiving intimate care
- Risk of harm due to inadequate code of behaviour
- Risk of harm in one-to-one teaching, counselling, coaching situation
- Risk of harm caused by member of school personnel communicating with pupils in an inappropriate manner via social media, texting, digital device or other manner
- Risk of harm caused by member of school personnel accessing/circulating inappropriate material via social media, texting, digital device or other manner
- Risk of harm caused by a pupil communicating with other pupils in an inappropriate manner or circulating inappropriate material via the same channels

**3. The school has the following procedures in place to address the risks of harm identified in this assessment -**

- All school employees are provided with a copy of the school's Child Safeguarding Statement and Risk Assessment and a copy of *The Child Protection Procedures for Primary and Post-Primary Schools 2017 (Revised 2023)*
- School Personnel are required to adhere to the *Child Protection Procedures for Primary and Post-Primary Schools 2017 (Revised 2023)* and all registered teaching staff are required to adhere to the *Children First Act 2015* and its Addendum (2019)
- The school adheres to the requirements of the National Vetting Bureau legislation and relevant DES circulars in relation to recruitment and vetting all employees and those in on placement
- All school employees are Garda vetted and all staff and Board Members have completed the Tusla Children First E-Learning programme
- Records of all staff and board members' Tusla Child Protection training are maintained.
- A session dedicated to Children First and Child Protection Guidelines is built into the Droichead process for newly qualified teachers
- The school has a Code of Conduct for school personnel (teaching and non-teaching staff)
- The school has well-supervised recreational periods and adheres to a yard/playground supervision roster to ensure appropriate and adequate supervision of children during arrival, assembly, breaktimes and dismissal
- The school has a Code of Behaviour which is communicated to pupils, parents and staff
- The school has in place a policy and procedures for the use of external persons to supplement delivery of the curriculum
  - The school has in place a policy and clear procedures in respect of school outings.

- A staff member is always present when a visitor is working with a class whether in-school or on field trips
- All bus escorts must provide proof of Garda vetting.
- Bus companies, Food providers, Music Generation and other organisations working in proximity to children will provide school with their child protection Policy.
- The school has a tour policy which adheres to Child protection guidelines with clear procedures in respect of school outings
- The school has an Anti-Bullying Policy, including Anti-cyber bullying, which fully adheres to the requirements of the Department's *Anti-Bullying Procedures for Primary and Post-Primary Schools for Adults and children*.
- In relation to the use of ICT, the school has an Acceptable Use Policy for Pupils and Adults in the school for which a declaration form must be signed
- The school has a Code of Conduct for school personnel (teaching and non-teaching staff)
- The school complies with the agreed disciplinary procedures for teaching staff
- The school has a Special Educational Needs policy
- The school has a Health and Safety policy
- The school has in place a policy and a set of procedures for the administration of First Aid. All staff are given First Aid training including defib training and training in respect to the administration of anapen medication
- The school has an Intimate care policy/ Toileting Plan in respect of students who require such care
- The school has a policy in place outlining procedures for the safe administration of medication to pupils
- All staff are aware of those pupils who are at risk of a medical episode and the medication they might require
- Teachers and SNAs are made aware of children who are flight risks and these children are supervised accordingly. The children are diamonded\* discreetly on our pupil information system and photos of the children are available to staff.
- The School gates close soon after start of school and remain closed except for admittance by appointment, until the dismissal times 1:50pm/2:50pm
- The school has a set of new secured gates in school yard, external and internal doors
- The school has a yard/playground supervision policy to ensure appropriate supervision of children during, arrival, assembly, dismissal and breaks and in respect of specific areas such as toilets, changing rooms etc.
- The school has a sign-in procedure for pupils being collected or dropped off at times other than dismissal times. Parents must come to the front desk and meet with staff before a child can be collected
- The school has a record of the people authorised to collect pupils
- The school has in place a policy governing the use of smartphones and tablet devices in the school by pupils as per circular 38/2018
- The school has an Acceptable Use Policy in place, to include provision for online teaching and learning remotely, and has communicated this policy to parents
- The school implements in full the Stay Safe Programme
- The school implements in full the SPHE curriculum
- The school implements Wellbeing programmes – Zippy and Friends, Friends for Life, Weaving Wellbeing, Fish Philosophy, Smart Moves Resilience Programme.
- The school has a Critical Incident Management Plan
- The school has a Distance Learning Plan and Remote Learning Policy outlining best practice and adhering to Children Protection Guidelines for unforeseen long-term school closure.

The board has put in place an action plan containing appropriate guidelines to address those aspects of the child's Safeguarding Statement or its implementation that have been identified as requiring further improvement

**Important Note:** It should be noted that risk in the context of this risk assessment is the risk of “harm” as defined in the Children First Act 2015 and not general health and safety risk. The definition of harm is set out in Chapter 4 of the *Child Protection Procedures for Primary and Post-Primary Schools (revised 2023)*

In undertaking this risk assessment, the board of management has endeavoured to identify as far as possible the risks of harm that are relevant to this school and to ensure that adequate procedures are in place to manage all risks identified. While it is not possible to foresee and remove all risk of harm, the school has in place the procedures listed in this risk assessment to manage and reduce risk to the greatest possible extent.

### **Examples of activities, risks and procedures**

The examples listed in this document are provided to assist schools in undertaking their risk assessment under the Children First Act, 2015. Schools should note that this list of examples is not intended to be exhaustive. It is the responsibility of each school to ensure, as far as possible, that any other risks and procedures that are relevant to its own particular circumstances are identified and specified in the written risk assessment and that adequate procedures are in place to address all risks identified.

It is acknowledged that schools already have in place a range of policies, practices and procedures to mitigate the risk of harm to children while they are participating in the activities of the school and that some school activities will carry low or minimal risks of harm compared to others. In the context of the risk assessment that must be undertaken by schools, the Children First Act, 2015 refers to risk as “any potential for harm”. Therefore, it is important that, as part of its risk assessment process, each school lists and reviews all of its various activities (which shall include identifying those that may carry low risk of harm as well as those that carry higher risks of harm). Doing so will help the school to (1) identify, as required under the Children First Act, 2015, any risks of harm that may exist in respect of the school’s activities, (2) identify and assess the adequacy of the various procedures already in place to manage those risks of harm and (3) identify and put in place any such additional procedures as are considered necessary to manage any risk identified.

The Addendum to *Children First: National Guidance for the Protection and Welfare of Children* published in January 2019 clarifies that organisations providing relevant services to children should consider the specific issue of online safety when carrying out their risk assessment and preparing their Child Safeguarding Statement.

The Guidance on Continuity of Schooling for primary and post-primary schools (April 2020) advises of the importance of teachers maintaining the safe and ethical use of the internet during distance learning and assisting parents and guardians to be aware of their role also. Schools should ensure that their Acceptable Use Policy (AUP) informs and guides remote or distance learning activity.

**Important Note:** It should be noted that risk in the context of this risk assessment is the risk of “harm” as defined in the Children First Act, 2015 and not general health and safety risk. - The school has in place a policy and clear procedures in respect of school outings
- The school has a health and safety policy
- The school adheres to the requirements of the Garda vetting legislation and relevant DE circulars in relation to recruitment and Garda vetting
- The school has a codes of conduct for school personnel (teaching and non-teaching staff)
- The school complies with the agreed disciplinary procedures for teaching staff
- The school has a Special Educational Needs policy
